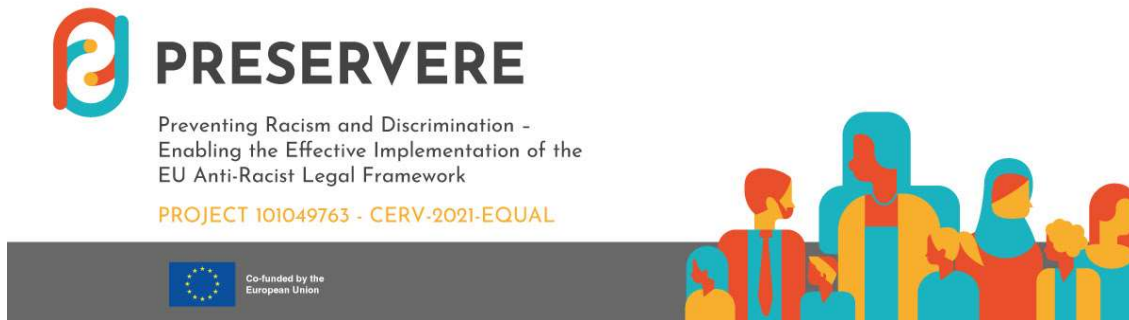

Dear reader,

we would share with you some important achievements of [Preservere](#) Project.

PRESERVERE - 'Preventing Racism and Discrimination: Enabling the Effective Implementation of the EU Anti-Racism Legal Framework' is an EU-funded project focusing on the more effective implementation of the EU anti-racism legal framework through the training of legal professionals and frontline workers.

It undertook **research** in 6 partner countries and developed **educational materials and tools** used to train **legal professionals** (judges, lawyers, prosecutors) and **frontline workers** (legal officers in prisons, the police, social services, reception asylum centers and border control authorities etc.) on how to use the nationally transposed European framework on anti-racism.

The project produced a series of **deliverables** that met his objectives, including:

Research activities:

13 Focus Groups with 70 legal professionals and frontline workers; **42 Interviews** to female legal professionals and frontline workers; Desktop research and Data collection.

Publications:

PRESERVERE E-BOOK #1 “The implementation of the EU anti-racism legal framework in 6 European states: Bulgaria, Cyprus, Greece, Italy, Malta, and the Netherlands”

One **European** and six **National Reports** on the implementation of the EU anti-racism legal framework.

PRESERVERE E-BOOK#2 “The PRESERVERE Project Implementation: Lessons Learned and Recommendations”.

A **White paper** offering key lessons about the Implementation of the project in 6 European countries: Bulgaria, Cyprus, Greece, Italy, Malta and The Netherland.
