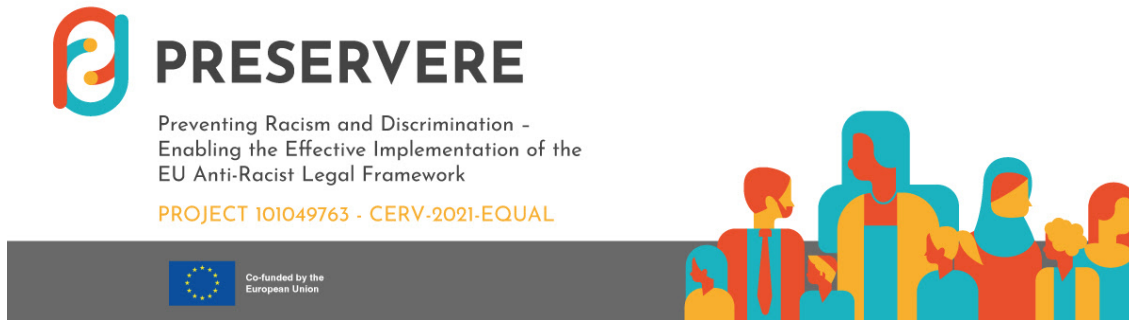

MANY ROMA **STILL FACE** THE LACK OF ACCESS TO ID_s

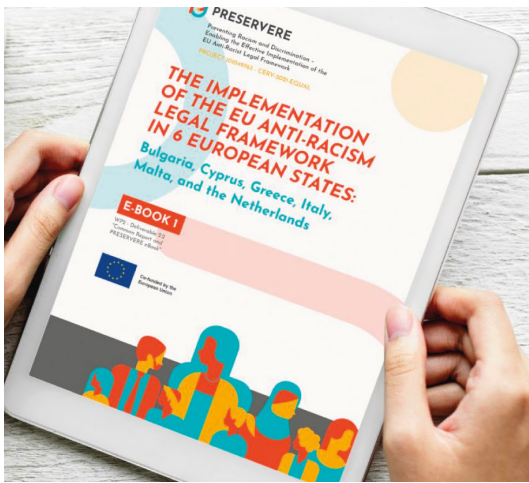
More than 200.000 Roma in Bulgaria still face the lack of access to identity documents. Also, more than 120.000 Roma never had one. This lack of rights is the premise of a violation of the Charter of Fundamental Rights of the EU, violating the right to equality before the law and non-discrimination.

PROTECTION AGAINST DISCRIMINATION ACT COMES
TO FORCE, BUT A **NATIONAL PLAN** IS STILL MISSING



The Bulgarian national legislation adopted the Protection Against Discrimination Act in 2004. Despite the above-mentioned legislation, it is important to highlight that there is no antidiscrimination or anti-racism plan at the national level. There is also no official national reporting on racist and hate related crime or other incidents, therefore data is fragmented and incomplete.
