LACK OF

GUIDANCE FOR FRONT-LINE WORKERS IN THE IMPLEMENTATION OF ANTI-RACISM EU DIRECTIVES



The discussion with the front-line workers revealed a complete lack of guidance and clarity in the way the Directives ought to be implemented in practice, including in regard to the duties and the obligations of persons working with vulnerable groups.



According to the EU Justice Scoreboard, Cypriot courts need the longest time in the EU to resolve cases. This constitutes the Cypriot judicial system one of the least efficient in the EU. Indeed, one of the cases relevant to this report was lodged in 2017 and was decided at first instance in March 2022.
