GREEK PUBLIC AUTHORITIES NEED **MORE TRAINING** ON THE EU DIRECTIVES

Greek legal framework and public authorities, including especially public services and the police, should be further involved, informed and trained on the application of the anti-racism legal framework. In fact, there is no state provision of training on the implementation of EU Directives.

OF MIGRANT POPULATION IS **FROM ALBANIA**, BUT THERE IS **NO ALBANIAN REPRESENTATIVE** IN POLITICAL PARTIES



Although Albanians represent a significant demographic in Greece (62% of the migrant population), none of the political parties feature Albanian representatives. Despite their economic, religious and cultural integration, Albanian immigrants or second-generation residents still face discriminatory behaviours.
