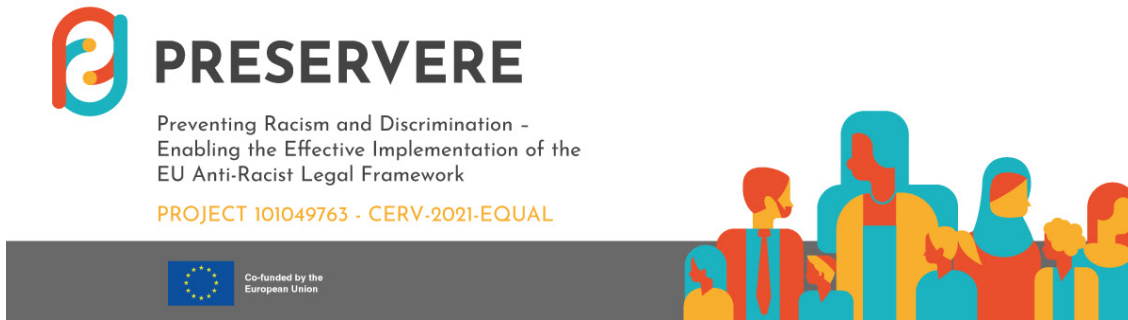

The complete implementation of the European Directives in Italy only passes through a jurisprudential elaboration of the issue. In fact, the crime of racial discrimination does not yet exist in the Italian legal system.

CONSTANT UPDATING ABOUT ANTI-DISCRIMINATION LEGAL FRAMEWORK IS NEEDED BY PRACTITIONERS



As regards the frontline workers' knowledge of European legislation, the focus groups and interviews revealed a general awareness of the Directives and their transposition into Italian law. However, almost all emphasised an incomplete mastery of the anti-discrimination discipline and the need for constant updating and in-depth study.
