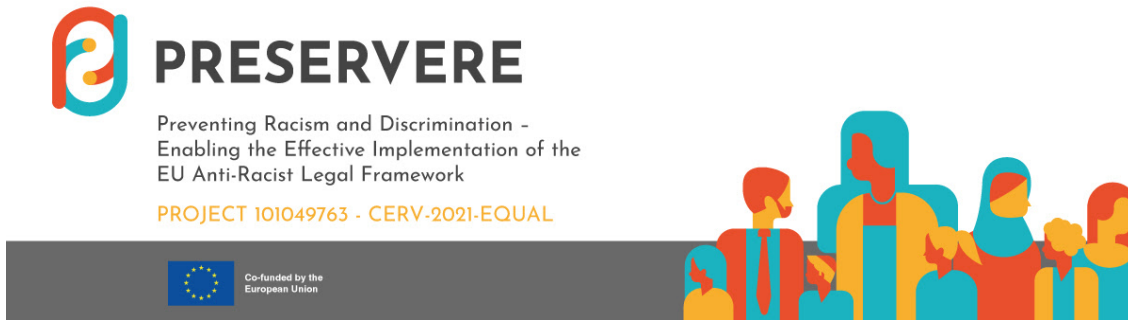

OF PERSONS OF **AFRICAN DESCENT** LIVE IN HOUSES THEY OWN COMPARED TO 81% OF THE GENERAL POPULATION



**Only 2% of persons of African** descent residing in Malta live in houses they own compared to 81% of the general population. The housing market is deeply unequal for people of African descent, who face discrimination because of their skin colour, ethnic origin, or religion.
