## IN THE NETHERLANDS, TRUST IN THE LEGAL SYSTEM IS DIFFERENT AMONG GENERATIONS OF IMMIGRANTS

In the Netherlands, the level of trust in the legal system among first- and second-generation of immigrants is lower than the national average. Many immigrants believe discrimination on grounds of ethnic origin or immigrant status is widespread in the country.

## EUROPEAN DIRECTIVES

ARE SUCCESSFULLY TRANSPOSED INTO THE NATIONAL LEGAL FRAMEWORK, BUT SOME SHORTCOMINGS REMAIN.



The Dutch legal framework has succeeded in transposing the two Directives into its national legal framework. However, there are some shortcomings related to their practical execution, such as inadequate fundings and lack of capacity with recognition of victims.
